1. One- and two-family dwellings when the total building heating/cooling system input rating is 375,000 Btu's or less.
2. Alterations and repair work determined by the Mechanical Inspector to be of minor nature.
3. Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not more than 3,500 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00

PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.

V. APPLICANT SIGNATURE

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or residential structure. VIII. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Items, quantities and inspections that are overlooked, unforeseen, or omitted from the original permit application will be billed to the permit holder. These additional fees must be paid prior to a final inspection being conducted. Mechanical work shall not be started until the application for permit has been approved by the Charter Township of Fort Gratiot. All installations shall be in conformance with the State Mechanical Code. No work shall be concealed until it has been inspected and approved. To schedule an inspection, contact the Building Department a minimum of 24 hours prior and be ready to provide the property address, permit number and type of inspection requested.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six (6) months of the permit being issued or if the authorized work is suspended or abandoned for a period of six (6) months after work has commenced. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX (6) MONTHS OF THE ISSUE DATE OR WITHIN SIX (6) MONTHS OF THE DATE OF THE LAST INSPECTION. CANCELLED PERMITS WILL NOT BE REFUNDED OR REINSTATED.**
